Schober, assistant attorney general. CONNOR T. HANSEN, J. Defendant Giese has raised four contentions on this review: 1. That a prima facie case was not made out against him. 2. That the refusal of the trial court to grant a continuance constituted an abuse of discretion. 3. That he was denied a fair trial because of comments made by the prosecutor concerning his prior convictions during his closing argument. 4. That the trial court erred in denying a motion to quash the information on the grounds that it failed to state facts constituting the offense with which he was charged. A prima facie case was made out. It is well established that a confession is evidence, and evidence alone may suffice to sustain a conviction if it proves the case. It need not be corroborated.[1] In the instant case, not only the confession, but the state's offer of proof of the circumstances surrounding it, and the various statements of defendant on *247 the night of his arrest, when considered together, was more than sufficient to prove the defendant guilty beyond a reasonable doubt.[2] The trial court did not abuse its discretion in denying a continuance. As to the contention that the prosecutor's closing argument constituted prejudicial error, we have examined the entire record and find that this is not the case.[3] The motion to quash the information was properly denied because it contained no reference to the penalty prescribed for the offense and did not specifically advise the defendant of the charge against him.[4] By the Court.
